This Pomeranian is being sold for the price of \$ \_\_\_\_\_. In addition, all expenses for preparation to ship plus shipping expenses are the responsibility of the buyer. The breeder must receive full payment by 9 weeks of age. This Pomeranian is sold with no warranties, either expressed or implied in "as is" condition with no guarantees other than those stated herein. Puppies go to their new homes between 12 to 16 weeks of age (at breeder determination). All payments and deposits are non-refundable.

It is understood that this Pomeranian must be shown and awarded an AKC championship title. The buyer will make every effort to title this Pomeranian. This dog will remain in co-ownership between the buyer and the breeder until the AKC championship title is awarded. All show expenses will be paid by the buyer. The buyer will provide a copy of a show photo and championship certificate to the breeder. The breeder will sign off of all registration documents pertaining to this dog when all terms of the contract have been met. Should anything unforeseen happen to the breeder (such as death), then full ownership will transfer to the co-owner.

This Pomeranian is being sold as a show prospect (defined as having no major or disqualifying faults for his or her age on the date of this sale). A definitive evaluation is made on puppies at 8 weeks and 18 months of age (per Pat Hastings Structure Evaluation) and cannot be made in between those ages. Males will have two testicles descended into the scrotum at maturity or a replacement will be made when one becomes available (replacement is the only option). I must receive a statement from your veterinarian by 7 months of age, stating that all remaining puppy teeth were extracted. If I do not receive this statement from your veterinarian, any guarantee you may have had on the bite is null and void.

The new owner has 48 hours from the date of shipping to have the Pomeranian examined by a veterinarian of their own choice, at their own expense. If the vet exam reveals that the Pomeranian is diseased or has a genetic defect, the buyer must return the Pomeranian along with a written statement from the attending vet as to the health problem, for a replacement Pomeranian when one becomes available. Replacement is the only option. Any difference in price will be the buyer's responsibility. Returning the Pomeranian will be at the buyer's expense. There is no guarantee against accidents. No veterinary bills will be paid by the breeder.

This Pomeranian is sold with no warranties, either expressed or implied in an "as is" condition with no guarantees other than those stated herein. All payments are non-refundable. This contract is entered into in the State of Iowa and will be interpreted and enforced under the laws of the State of Iowa. This contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied are included unless specifically stated herein. When breeder and buyer execute this contract, it will be binding upon both parties, subject and pursuant to the terms and conditions herein.

It is agreed that at no time will the owner sell or give this Pomeranian or any of his offspring to a pet store, a puppy mill operation, a dog pound, or a dog broker or any similar enterprise or sell at auction. In the event that the owner needs to find a new home for this Pomeranian, the breeder will be offered first right of refusal. All offspring will be sold to show exhibitors, or sold on a spay/neuter contract.
